1. Provincial Coordinator PM's Program for Prevention & Control of Hepatitis KP, Directorate General Health Services Khyber Pakhtunkhwa, Khyber Road, Peshawar invites sealed bids from the Manufacturers & authorized agents of Diagnostic kits for the financial year 2017-18.
2. Application Form along with SBD can be obtained from the office of Provincial Coordinator PM's Program for Prevention & Control of Hepatitis, Directorate General Health Services, Khyber Road Peshawar during office hours on any working day till **Monday, 26 March, 2018**, against the cash payment of Pak Rupees Two Thousand (Rs.2000/-). Original receipt of the paid amount must be attached with the Technical Bid inside its sealed envelope. The same can also be downloaded from [www.healthkp.gov.pk](http://www.healthkp.gov.pk)
3. Bidding competition shall be conducted through **Single Stage–Two Envelopes Bidding Procedure** as per KPPRA Rules-2014.
4. The successful bidder will have to provide fifteen (15) PCR machines for various sentinel sites all over the province on reagent basis.
5. A pre-Bid meeting will be held on 19<sup>th</sup> March, 2018 at 11:00am in the conference room of DGHS.
6. Mandatory Bid Security / Earnest Money amounting to a flat rate of Rs. 600000/- for PCR Kits and Rs. 200000/- for Rapid kits, from each bidder in the shape of Pay Order (PO) / Demand Draft (DD) / Call Deposit Receipt (CDR) / Bankers Cheques in the name of the Provincial Coordinator PM's Program for Prevention & Control of Hepatitis KP is required to be submitted along with the Financial Bid within its sealed envelope. An affidavit to this effect should be placed in technical proposal, failing which bid shall be considered as 'non-responsive'
7. Bidders are required to offer most competitive lowest price of their quoted item/s as no negotiations on quoted price are allowed under the rules.
8. Bids will be opened by the Procurement Committee of PM's Program for Prevention & Control of Hepatitis KP at **11:30 A.m** Monday, 26<sup>th</sup> March, 2018 in the Conference Room of Directorate General Health Services, Khyber Road, Peshawar in the presence of those bidders or their authorised representatives, who choose to attend the bids opening process.
