Firms, shall submit the Bid Security in an envelope containing financial bids in the shape of Pay Order (PO)/Demand Draft (DD)/Call Deposit Receipt (CDR) equal to **2%** of their bid amount in the name of Project Director, Integrated Health Project, Department of Health, Khyber Pakhtunkhwa. The bidders shall submit an undertaking/affidavit in their Technical Bids that the requisite Bid Security is included in their Financial Bid without mentioning the amount.
5. Late bids will be treated as non-responsive. No bid will be accepted after 10:30 a.m. on 03/05/2018.
6. The Bidders are requested to give their best and final price for as per specifications given in Standard Bidding Documents as no negotiation on the prices is allowed. The bid must be valid up to **120 days from date of opening of the bid**.
